MEMBERSHIP CATEGORIES AND SUBSCRIPTIONS 2018

CATEGORY	DESCRIPTION
ORDINARY	Full member is entitled to make use of all Club facilities and activities and entitled to one vote at AGM or EGM.
FAMILY	Full membership for two adults plus family members under 17 years old (living at the same address) on 1 January 2018, either adult is entitled to one vote at AGM or EGM.
UNDER 23	Full member under 23 years old on 1 January 2018 and entitled to one vote at AGM or EGM.
JUNIOR	Must be under 17 years old on 1 January 2018 do not have voting rights at AGM or EGM.
ASSOCIATE	Social member who must be over 18 on 1 January 2018 and are only entitled to use the social facilities of the Club. Associate members do not have voting rights at AGM or EGM.
GROUPS	Available to organisations that serve the local community or who subscribe to one or more of the purpose of the club. Group members do not have voting rights at AGM or EGM.
HONORARY	This form is for personal information updates and do not have voting rights at AGM or EGM.
