## Membership categories and descriptions 2020

ORDINARY	Full member is entitled to make use of all Club facilities and activities, and entitled to one vote at AGM or EGM.
FAMILY	Full membership for two adults plus family members under 17 years old (living at the same address) on 1 January 2020. Either adult is entitled to one vote at AGM or EGM.
UNDER 23	Full member under 23 years old on 1 January 2020 and entitled to one vote at AGM or EGM.
JUNIOR	Must be under 17 years old on 1 January 2020. Do not have voting rights at AGM or EGM.
ASSOCIATE	Social member who must be over 18 on 1 January 2020 and are only entitled to use the social facilities of the Club. Associate members do not have voting rights at AGM or EGM.
GROUPS	Available to organisations that serve the local community or which subscribe to one or more of the purposes of the club. Group members do not have voting rights at AGM or EGM.
HONORARY	Nominated by the board, primarily for long service to the club. Do not have voting rights at AGM or EGM.
